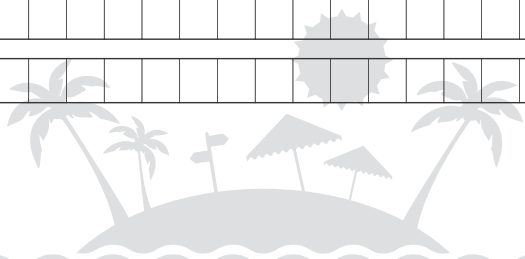

TERMS AND CONDITIONS

1. Passport requirement:- The passport should be valid for minimum 06 months from the date of arrival.
2. As of now we are not holding any service, all services will be subject to re-confirmation on the date of booking.
3. The 4N/5D Thailand holiday package is redeemable in any of the below season.
 - Season 1- from 1st Sep, 2017 to 15th Dec, 2017
 - Season 2- from 15th Jan, 2018 to 30th Apr, 2018
4. Free look period shall be of 7 days. The customer can within 7 days from the date of purchase intimate in writing to the company stating their wish to cancel the purchase, the same shall entitle them for full refund. By selecting the date of travel/check in the customer, unconditionally, waives his right attached to the free look period policy irrespective of the days of purchase.
5. The customer can change the name of the traveller from the name mentioned in the KYC form one time, at a nominal charge of INR 1000+GST.
6. The customer can change the season of travel from the selection made in this KYC, one time, at a nominal charge of INR 3,000+GST.
7. Once the booking is confirmed for a date as per point 2 above, the customer can change the date of travel, before 15 clear days, between the date of change request and date of check in, at a nominal charge of INR 2500+GST. No changes shall be allowed for a shorter clear days.
8. Company follows a strict policy of no show no refund.
9. The booking needs to be reconfirmed with the company by e-mail at least 15(clear) days prior to intended date of Check-in.
10. The booking will thereafter be re-confirmed by our operations team by e-mail and thereafter client/s will be considered as booked to travel.
11. Choice of hotel is not available in "TVP", mentioned or similar hotel will be provided (kindly check hotel rating and other details on respective website of hotels).
12. SIC means Seat-in-Coach basis. A coach may cover 4 to 5 hotels enroute.
13. This is a promotional package which is available only for limited seats which cannot be hold and are subject to availability of seats on selected departure dates.
14. Package Cost includes (Ground handling charges) Dollar segment, which will be taken out of your BTQ (Basic Travel Quota)
15. Room type (Double or twin) is subject to availability and sole discretion of the hotel.
16. Hotel Check in time is 2 PM to 4 PM.
17. BREAKFAST: Fixed breakfast as per hotel discretion.

26. All Tour packages offered by us are governed by the terms and conditions and undertakings in the package tour - service agreement along with the booking form, which are incorporated herein by reference.
27. The time schedule fixed by the local tour operator should be strictly adhered to. For any inconvenience, loss or consequence suffered due to tourist's failure to keep the local tour operators timings, the tourist alone would be responsible.
